Ronald McDonald House:
In 2012 Ronald McDonald House provided a home away from home for 1,895 families and 5,483 family members of seriously ill children. In addition to providing a place to sleep in one of our 36 guestrooms, we offered families laundry facilities, meals prepared by volunteers, and more. The average stay at Ronald McDonald House was 6.3 days, and 522 families stayed one week or longer.

Ronald McDonald House Charities of Kentuckiana Grants and Scholarships:
Ronald McDonald House Charities of Kentuckiana is committed to supporting local organizations that serve children through its grantmaking program, and it also supports higher education by providing scholarships to college students. In 2012, sixteen organizations received grants totaling over \$90,500 (including matching funds from RMHC Global), and twenty-three students received scholarships totaling \$54,000.

Ronald McDonald Family Rooms:
Our Ronald McDonald Family Rooms take the concept of a freestanding Ronald McDonald House, then move it inside the hospital. In 2012, Ronald McDonald House Charities of Kentuckiana operated three Ronald McDonald Family Rooms. Over 1,210 families have been provided a home away from home inside Kosair Children's Hospital, Norton Suburban Hospital and Frazier Rehab Institute.
